1 The regulations in Table A as in force at the date of the incorporation of the Company shall not apply to the Company

Definitions

2 In these Articles, except where the subject or context otherwise requires

Act means the Companies Act 2006 including any modification or re-enactment of it for the time being in force,

Articles means these articles of association as altered from time to time by special resolution,

Auditors means the auditors of the Company,

the Board means the Directors or any of them acting as the board of Directors of the Company,

Certificated Share means a share in the capital of the Company that is not an Uncertificated Share and references in these Articles to a share being held in

certificated form shall be construed accordingly,

Clear Days in relation to the period of a notice means that period calculated in accordance with section 360 of the Act,

Communication has the same meaning as in section 15 of the Electronic Communications Act,

Companies Acts has the meaning given by section 2 of the Act and includes any enactment passed after those Acts which may, by virtue of that or any other such enactment, be cited together with those Acts as the "**Companies Acts**" (with or without the addition of an indication of the date of any such enactment),

Company's website means any websites, operated or controlled by the Company, which contain information about the Company in accordance with the Statutes,

Director means a director of the Company,

Dividend means dividend or bonus,

Electronic Communication has the same meaning as in section 15 of the Electronic Communications Act,

Electronic Communications Act means the Electronic Communications Act 2000 (as amended from time to time),

Electronic Facility includes, without limitation, website addresses and conference call systems, and any device, system, procedure, method or other facility whatsoever providing an Electronic Means of attendance at or participation in (or both attendance at and participation in) a general meeting determined by the Board pursuant to Article 50 1

Electronic Form has the meaning given in section 1168 of the Act

Electronic Means has the meaning given in section 1168 of the Act

entitled by transmission means, in relation to a share in the capital of the Company, entitled as a consequence of the death or bankruptcy of the holder or otherwise by operation of law,

executed includes any mode of execution including electronic execution as provided for by the Electronic Communications Act,

holder in relation to a share in the capital of the Company means the member whose name is entered in the register as the holder of that share,

London Stock Exchange means London Stock Exchange Limited,

member means a member of the Company,

month means a calendar month,

office means the registered office of the Company,

paid means paid or credited as paid,

Recognised Person means a recognised clearing house or a nominee of a recognised clearing house or of a recognised investment exchange, each of which terms has the meaning given to it by section 778 of the Act,

Register means the register of members of the Company,

Regulations means the Uncertificated Securities Regulations 2001 (SI 2001 No 2001/3755) (as amended from time to time),

Relevant System means a computer based system, and procedures, enabling title to shares to be evidenced and transferred without a written instrument, as defined in the Regulations,

seal means the common seal of the Company and includes any official seal kept by the Company by virtue of section 49 or 50 of the Act,

secretary means the secretary of the Company and includes a joint, assistant, deputy or temporary secretary and any other person appointed to perform the duties of the secretary,

Shareholder Information means notices, documents or information which the Company wishes or is required to communicate to shareholders including, without limitation, annual reports and accounts, interim financial statements, summary financial statements, notices of meetings and proxy forms,

Statutes means the Act, the Companies Acts 1985 and 1989, and every other statute (including any orders, regulations or other subordinate legislation made under them) for the time being in force concerning companies and affecting the Company (including, without limitation, the Electronic Communications Act),

Uncertificated Share means a share in the capital of the Company which is recorded on the register as being held in uncertificated form and title to which may, by virtue of the Regulations, be transferred by means of a Relevant System and references in these Articles to a share being held in uncertificated form shall be construed accordingly,

United Kingdom means Great Britain and Northern Ireland, and

Website Communication means the publication of a notice or other Shareholder Information on the Company's website in accordance with Part 4 of Schedule 5 to the Act

Construction

3 References to a document being executed include references to its being executed under hand or under seal or by any other method

References to writing include references to any visible substitute for writing and to anything partly in one form and partly in another form

Words denoting the singular number include the plural number and vice versa, words denoting the masculine gender include the feminine gender, and words denoting persons include corporations

Words or expressions contained in these Articles which are not defined in Article 2 but are defined in the Act have the same meaning as in the Act (but excluding any modification of the Act not in force at the date of adoption of these Articles) unless inconsistent with the subject or context

Words or expressions contained in these Articles which are not defined in Article 2 but are defined in the Regulations have the same meaning as in the Regulations (but excluding any modification of the Regulations not in force at the date of adoption of these Articles) unless inconsistent with the subject or context

Subject to the preceding two paragraphs, references to any provision of any enactment or of any subordinate legislation (as defined by section 21(1) of the Interpretation Act 1978) include any modification or re-enactment of that provision for the time being in force

Headings and marginal notes are inserted for convenience only and do not affect the construction of these Articles

In these Articles, (a) powers of delegation shall not be restrictively construed but the widest interpretation shall be given to them, (b) the word **board** in the context of the exercise of any power contained in these Articles includes any committee consisting of one or more Directors, any Director holding executive office and any local or divisional board, manager or agent of the Company to which or, as the case may be, to whom the power in question has been delegated, (c) no power of delegation shall be limited by the existence of or, except where expressly provided by the terms of delegation, the exercise of, that or any other power of delegation, and (d) except where expressly provided by the terms of delegation, the delegation of a power shall not exclude the concurrent exercise of that power by any other body or person who is for the time being authorised to exercise it under these Articles or under another delegation of the power

Where, in relation to a share, these Articles refer to a Relevant System, the reference is to the Relevant System in which that share is a participating security at the relevant time

REGISTERED OFFICE

Registered office 4 The Company's registered office is to be situated in England and Wales

LIMITED LIABILITY

Limited Liability 5 The liability of the members is limited

CHANGE OF NAME

Change of name 6 The Company may change its registered name in accordance with the Statutes or by majority decision of the Board

SHARE CAPITAL

Shares with special rights 7 1 Subject to the provisions of the Companies Acts and without prejudice to any rights attached to any existing shares or class of shares, any share may be issued with such rights or restrictions as the Company may by ordinary resolution determine or, subject to and in default of such determination, as the Board shall determine

Share warrants to bearer 7 2 The Board may issue share warrants to bearer in respect of any fully paid shares under a seal of the Company or in any other manner authorised by the Board Any share while represented by such a warrant shall be transferable by delivery of the warrant relating to it In any case in which a warrant is so issued, the Board may provide for the payment of Dividends or other monies on the shares represented by the warrant by coupons or otherwise The Board may decide, either generally or in any particular case or cases, that any signature on a warrant may be applied by mechanical means or printed on it or that the warrant need not be signed by any person

Conditions of issue of share warrants 7 3 The Board may determine, and from time to time vary, the conditions on which share warrants to bearer shall be issued and, in particular, the conditions on which

- (a) a new warrant or coupon shall be issued in place of one worn-out, defaced, lost or destroyed (but no new warrant shall be issued unless the Company is satisfied beyond reasonable doubt that the original has been destroyed), or

- (b) the bearer shall be entitled to attend and vote at general meetings, or
- (c) a warrant may be surrendered and the name of the bearer entered in the register in respect of the shares specified in the warrant

The bearer of such a warrant shall be subject to the conditions for the time being in force in relation to the warrant, whether made before or after the issue of the warrant. Subject to those conditions and to the provisions of the Companies Acts, the bearer shall be deemed to be a member of the Company and shall have the same rights and privileges as he would have if his name had been included in the register as the holder of the shares comprised in the warrant.

No right in relation to share 7.4 The Company shall not be bound by or be compelled in any way to recognise any right in respect of the share represented by a share warrant other than the bearer's absolute right to the warrant.

Uncertificated Shares 8.1 Subject to the provisions of the Regulations, the Board may permit the holding of shares in any class of shares in uncertificated form and the transfer of title to shares in that class by means of a Relevant System and may determine that any class of shares shall cease to be a participating security.

Not separate class of shares 8.2 Shares in the capital of the Company that fall within a certain class shall not form a separate class of shares from other shares in that class because any share in that class

- (a) is held in uncertificated form, or
- (b) is permitted in accordance with the Regulations to become a participating security.

Exercise of Company's entitlements in respect of Uncertificated Share 8.3 Where any class of shares is a participating security and the Company is entitled under any provision of the Companies Acts, the Regulations or the Articles to sell, transfer or otherwise dispose of, forfeit, re-allot, accept the surrender of or otherwise enforce a lien over a share held in uncertificated form, the Company shall be entitled, subject to the provisions of the Companies Acts, the Regulations, these Articles and the facilities and requirements of the Relevant System

- (a) to require the holder of that Uncertificated Share by notice to change that share into certificated form within the period specified in the notice and to hold that share in certificated form so long as required by the Company,
- (b) to require the holder of that Uncertificated Share by notice to give any

instructions necessary to transfer title to that share by means of the Relevant System within the period specified in the notice,

- (c) to require the holder of that Uncertificated Share by notice to appoint any person to take any step, including without limitation the giving of any instructions by means of the Relevant System, necessary to transfer that share within the period specified in the notice, and
- (d) to take any action that the Board considers appropriate to achieve the sale, transfer, disposal, forfeiture, re-allotment or surrender of that share or otherwise to enforce a lien in respect of that share

Redeemable shares 9 Subject to the provisions of the Companies Acts, and without prejudice to any rights attached to any existing shares or class of shares, shares may be issued which are to be redeemed or are to be liable to be redeemed at the option of the Company or the holder on such terms and in such manner as may be determined by the Board (and, if so fixed, the date or dates allotted)

Commissions 10 The Company may exercise all powers of paying commissions or brokerage conferred or permitted by the Companies Acts Subject to the provisions of the Companies Acts, any such commission or brokerage may be satisfied by the payment of cash or by the allotment of fully or partly paid shares or partly in one way and partly in the other

Trusts not recognised 11 Except as otherwise provided by these Articles or required by law, the Company shall recognise no person as holding any share on any trust and the Company shall not be bound by or recognise any interest in any share (or in any fractional part of a share) except the holder's absolute right to the entirety of the share (or fractional part of the share)

VARIATION OF RIGHTS

Method of varying rights 12 1 Subject to the provisions of the Companies Acts, if at any time the capital of the Company is divided into different classes of shares, the rights attached to any class may (unless otherwise provided by the terms of allotment of the shares of that class) be varied or abrogated, whether or not the Company is being wound up, either with the consent in writing of the holders of three-quarters in nominal value of the issued shares of the class or with the sanction of a special resolution passed at a separate general meeting of the holders of the shares of the class (but not otherwise)

When rights deemed to be varied 12 2 For the purposes of this Article, if at any time the capital of the Company is divided into different classes of shares, unless otherwise expressly provided by the rights attached to any share or class of shares, those rights shall be deemed to

be varied by

- (a) the reduction of the capital paid up on that share or class of shares otherwise than by a purchase or redemption by the Company of its own shares, and
- (b) the allotment of another share ranking in priority for payment of a Dividend or in respect of capital or which confers on its holder voting rights more favourable than those conferred by that share or class of shares,

but shall not be deemed to be varied by

- (c) the creation or issue of another share ranking equally with, or subsequent to, that share or class of shares or by the purchase or redemption by the Company of its own shares, or
- (d) the Company permitting, in accordance with the Regulations, the holding of and transfer of title to shares of that or any other class in uncertificated form by means of a Relevant System

SHARE CERTIFICATES

Members' rights to certificates

13 Every member, on becoming the holder of any Certificated Share (except a Recognised Person in respect of whom the Company is not required by law to complete and have ready for delivery a certificate) shall be entitled, without payment, to one certificate for all the Certificated Shares of each class held by him (and, on transferring a part of his holding of Certificated Shares of any class, to a certificate for the balance of his holding of Certificated Shares) He may elect to receive one or more additional certificates for any of his Certificated Shares if he pays for every certificate after the first a reasonable sum determined from time to time by the Board Every certificate shall

- (a) be executed under the seal or otherwise in accordance with Article 132 or in such other manner as the Board may approve, and
- (b) specify the number, class and distinguishing numbers (if any) of the shares to which it relates and the nominal value of and the amount or respective amounts paid up on the shares

The Company shall not be bound to issue more than one certificate for Certificated Shares held jointly by more than one person and delivery of a certificate to one joint holder shall be a sufficient delivery to all of them Shares of different classes may not be included in the same certificate

Replacement certificates 14 If a share certificate is defaced, worn out, lost or destroyed, it may be renewed on such terms (if any) as to evidence and indemnity and payment of any exceptional out-of-pocket expenses reasonably incurred by the Company in investigating evidence and preparing the requisite form of indemnity as the Board may determine but otherwise free of charge, and (in the case of defacement or wearing out) on delivery up of the old certificate

LIEN

Company to have lien on shares 15 The Company shall have a first and paramount lien on every share (not being a fully paid share) for all monies payable to the Company (whether presently or not) in respect of that share. The Board may at any time (generally or in a particular case) waive any lien or declare any share to be wholly or in part exempt from the provisions of this Article. The Company's lien on a share shall extend to any amount (including without limitation Dividends) payable in respect of it. Unless otherwise agreed, the registrations of a transfer of a share shall operate as a waiver of the Company's liens, if any, on a Share

Enforcement of lien by sale 16.1 The Company may sell, in such manner as the Board determines, any share on which the Company has a lien if a sum in respect of which the lien exists is presently payable and is not paid within 14 Clear Days after notice has been given to the holder of the share, or to the person entitled to it by transmission, demanding payment and stating that if the notice is not complied with the share may be sold

Giving effect to sale 16.2 To give effect to that sale the Board may, if the share is a Certificated Share, authorise any person to execute an instrument of transfer in respect of the share sold to, or in accordance with the directions of, the buyer. If the share is an Uncertificated Share, the Board may exercise any of the Company's powers under Article 8.3 to effect the sale of the share to, or in accordance with the directions of, the buyer. The buyer shall not be bound to see to the application of the purchase monies and his title to the share shall not be affected by any irregularity in or invalidity of the proceedings in relation to the sale

Application of proceeds 16.3 The net proceeds of the sale, after payment of the costs, shall be applied in or towards payment or satisfaction of so much of the sum in respect of which the lien exists as is presently payable. Any residue shall (if the share sold is a Certificated Share, on surrender to the Company for cancellation of the certificate in respect of the share sold and, whether the share sold is a certificated or Uncertificated Share, subject to a like lien for any monies not presently payable as existed on the share before the sale) be paid to the person entitled to the share immediately before the date of the sale

CALLS ON SHARES

- Power to make calls 17 Subject to the terms of allotment, the Board may from time to time send a notice and make calls on the members in respect of any monies unpaid on their shares (whether in respect of nominal value or premium) Each member shall (subject to the Company having given him at least 14 Clear Days' notice from the date the notice is sent specifying when and where payment is to be made) pay to the Company the amount called on his shares as required by the notice A call may be revoked in whole or part and the time fixed for payment of a call may be postponed in whole or part as the Board may determine A person on whom a call is made shall remain liable for calls made on him even if the shares in respect of which the call was made are subsequently transferred
- Time when call made 18 A call may be made payable by instalments
- Liability of joint holders 19 The joint holders of a share shall be jointly and severally liable to pay all calls in respect of it
- Interest payable 20 If a call or any instalment of a call remains unpaid in whole or in part after it has become due and payable the person from whom it is due and payable shall pay interest on the amount unpaid from the day it became due and payable until it is paid Interest shall be paid at the rate fixed by the terms of allotment of the share or in the notice of the call or, if no rate is fixed, the rate determined by the Board, not exceeding 5 per cent above the base lending rate per annum most recently set by the Monetary Policy Committee of the Bank of England or, if higher, the appropriate rate (as defined by the Companies Acts), but the Board may in respect of any individual member waive payment of such interest wholly or in part
- Deemed calls 21 An amount payable in respect of a share on allotment or at any fixed date, whether in respect of nominal value or premium or as an instalment of a call, shall be deemed to be a call duly made and notified and payable on the date so fixed or in accordance with the terms of the allotment If it is not paid the provisions of these Articles shall apply as if that amount had become due and payable by virtue of a call duly made and notified
- Differentiation on calls 22 Subject to the terms of allotment, the Board may make arrangements on the issue of shares for a difference between the allottees or holders in the amounts and times of payment of calls on their shares
- Payment of calls in advance 23 The Board may, if it thinks fit, receive from any member all or any advance part of the monies uncalled and unpaid on any share held by him Such payment in advance of calls shall extinguish the liability on the share in respect of which it is made to the extent of the payment The Company may pay on all

or any of the monies so advanced (until they would but for such advance become presently payable) interest at such rate agreed between the Board and the member not exceeding 5 per cent above the base lending rate per annum most recently set by the Monetary Policy Committee of the Bank of England or, if higher, the appropriate rate (as defined in the Companies Acts)

FORFEITURE AND SURRENDER

- Notice requiring payment of call 24 If a call or any instalment of a call remains unpaid in whole or in part after it has become due and payable, the Board may give to the person from whom it is due not less than 14 Clear Days' notice requiring payment of the amount unpaid together with any interest which may have accrued and any costs, charges and expenses incurred by the Company by reason of such non-payment. The notice shall name the place where payment is to be made and shall state that if the notice is not complied with the shares in respect of which the call was made will be liable to be forfeited.
- Forfeiture for non-compliance 25 If that notice is not complied with, any share in respect of which it was given may, at any time before the payment required by the notice has been made, be forfeited by a resolution of the Board. The forfeiture shall include all Dividends or other monies payable in respect of the forfeited share which have not been paid before the forfeiture. When a share has been forfeited, notice of the forfeiture shall be served on the person who was the holder of the share before the forfeiture. An entry shall be made promptly in the register opposite the entry of the share showing that notice has been served, that the share has been forfeited and the date of forfeiture. No forfeiture shall be invalidated by the omission or neglect to give that notice or to make those entries.
- Sale of forfeited shares 26 Subject to the provisions of the Companies Acts, a forfeited share shall be deemed to belong to the Company and may be sold, re-allotted or otherwise disposed of on such terms and in such manner as the Board determines, either to the person who was the holder before the forfeiture or to any other person. At any time before sale, re-allotment or other disposal, the forfeiture may be cancelled on such terms as the Board thinks fit. Where for the purposes of its disposal a forfeited share held in certificated form is to be transferred to any person, the Board may authorise any person to execute an instrument of transfer of the share to that person. Where for the purposes of its disposal a forfeited share held in uncertificated form is to be transferred to any person, the Board may exercise any of the Company's powers under Article 8.3. The Company may receive the consideration given for the share on its disposal and may register the transferee as holder of the share.
- Liability following forfeiture 27 A person shall cease to be a member in respect of any share which has been forfeited and shall, if the share is a Certificated Share, surrender the

certificate for any forfeited share to the Company for cancellation. The person shall remain liable to the Company for all monies which at the date of forfeiture were presently payable by him to the Company in respect of that share with interest on that amount at the rate at which interest was payable on those monies before the forfeiture or, if no interest was so payable, at the rate determined by the Board, not exceeding 5 per cent above the base lending rate per annum most recently set by the Monetary Policy Committee of the Bank of England or, if higher, the appropriate rate (as defined in the Companies Acts), from the date of forfeiture until payment. The Board may waive payment wholly or in part or enforce payment without any allowance for the value of the share at the time of forfeiture or for any consideration received on its disposal.

Surrender 28 The Board may accept the surrender of any share which it is in a position to forfeit on such terms and conditions as may be agreed. Subject to those terms and conditions, a surrendered share shall be treated as if it had been forfeited.

Extinction of rights 29 The forfeiture of a share shall involve the extinction at the time of forfeiture of all interest in and all claims and demands against the Company in respect of the share and all other rights and liabilities incidental to the share as between the person whose share is forfeited and the Company, except only those rights and liabilities expressly saved by these Articles, or as are given or imposed in the case of past members by the Companies Acts.

Evidence of forfeiture or surrender 30 A statutory declaration by a Director or the secretary that a share has been duly forfeited or surrendered on a specified date shall be conclusive evidence of the facts stated in it as against all persons claiming to be entitled to the share. The declaration shall (subject if necessary to the execution of an instrument of transfer or transfer by means of the Relevant System, as the case may be) constitute a good title to the share. The person to whom the share is disposed of shall not be bound to see to the application of the purchase monies, if any, and his title to the share shall not be affected by any irregularity in, or invalidity of, the proceedings in reference to the forfeiture, surrender, sale, re-allotment or disposal of the share.

Sale of forfeited share 31 If the Company sells a forfeited share, the person who held it prior to its forfeiture is entitled to receive from the Company the proceeds of such sale, net of any commission, and excluding any amount which was, or would have become, payable and had not, when that share was forfeited, been paid by that person in respect of that share, but no interest is payable to such person in respect of such proceeds and the Company is not required to account for any money earned on them.

TRANSFER OF SHARES

Form and execution of transfer of Certificated Share	32 The instrument of transfer of a Certificated Share may be in any usual form or in any other form which the Board may approve. An instrument of transfer shall be signed by or on behalf of the transferor and, unless the share is fully paid, by or on behalf of the transferee. An instrument of transfer need not be under seal.
Transfers of partly paid Certificated Shares	33 The Board may, in its absolute discretion and without giving any reason, refuse to register the transfer of a Certificated Share which is not fully paid, provided that the refusal does not prevent dealings in shares in the Company from taking place on an open and proper basis.
Invalid transfers of Certificated Shares	34 1 The Board may also refuse to register the transfer of a Certificated Share unless the instrument of transfer <ul style="list-style-type: none"> (a) is lodged, duly stamped (if stampable), at the office or at another place appointed by the Board accompanied by the certificate for the share to which it relates and such other evidence as the Board may reasonably require to show the right of the transferor to make the transfer, (b) is in respect of only one class of shares, and (c) is in favour of not more than four transferees
Transfers by Recognised Persons	34 2 In the case of a transfer of a Certificated Share by a Recognised Person, the lodgement of a share certificate will only be necessary if and to the extent that a certificate has been issued in respect of the share in question. <p>34 3 The Board may, in its absolute discretion, and without giving any reason, refuse to register any transfer of an Uncertificated Share where permitted by the Regulations.</p>
Notice of refusal to register	35 If the Board refuses to register a transfer of a share, it shall send the proposed transferee notice of its refusal within two months after the date on which the instrument of transfer was lodged with the Company or the Operator-instruction was received, as the case may be.
No fee payable on registration	36 No fee shall be charged for the registration of any instrument of transfer or other document relating to or affecting the title to a share.
Retention of transfers	37 The Company shall be entitled to retain an instrument of transfer which is registered, but an instrument of transfer which the Board refuses to register shall (except in any case of fraud) be returned to the person lodging it when notice of the refusal is given.

TRANSMISSION OF SHARES

- Transmission 38 If a member dies, the survivor or survivors where he was a joint holder, and his personal representatives where he was a sole holder or the only survivor of joint holders, shall be the only persons recognised by the Company as having any title to his interest. Nothing in these Articles shall release the estate of a deceased member (whether a sole or joint holder) from any liability in respect of any share held by him.
- Elections permitted 39.1 A person becoming entitled by transmission to a share may, on production of any evidence as to his entitlement properly required by the Board, elect either to become the holder of the share or to have another person nominated by him registered as the transferee. If he elects to become the holder he shall give notice to the Company to that effect. If he elects to have another person registered and the share is a Certificated Share, he shall execute an instrument of transfer of the share to that person. If he elects to have himself or another person registered and the share is an Uncertificated Share, he shall take any action the Board may require (including without limitation the execution of any document and the giving of any instruction by means of a Relevant System) to enable himself or that person to be registered as the holder of the share. All the provisions of these Articles relating to the transfer of shares apply to that notice or instrument of transfer as if it were an instrument of transfer executed by the member and the death or bankruptcy of the member or other event giving rise to the transmission had not occurred.
- Elections required 39.2 The Board may at any time give notice requiring any such person to elect either to be registered himself or to transfer the share. If the notice is not complied with within 60 days, the Board may after the expiry of that period withhold payment of all Dividends or other monies payable in respect of the share until the requirements of the notice have been complied with.
- Rights of persons entitled by transmission 40 A person becoming entitled by transmission to a share shall, on production of any evidence as to his entitlement properly required by the Board and subject to the requirements of Article 39, have the same rights in relation to the share as he would have had if he were the holder of the share, subject to Article 142. That person may give a discharge for all Dividends and other monies payable in respect of the share, but he shall not, before being registered as the holder of the share, be entitled in respect of it to receive notice of, or to attend or vote at, any meeting of the Company or to receive notice of or to attend or vote at any separate meeting of the holders of any class of shares in the capital of the Company.

ALTERATION OF SHARE CAPITAL

Alterations by ordinary resolution	41	The Company may by ordinary resolution alter its share capital in accordance with the Act
Sub-division of shares	42	A resolution to sub-divide shares, may determine that, as between the holders of such shares resulting from the sub-division, any of them may have any preference or advantage or be subject to any restriction as compared with the others

Contents of notice general 49 1 The notice shall specify the time and place of the meeting (including without limitation any satellite meeting place or Electronic Facility or facilities arranged for the purposes of Article 50 1, which shall be identified as such in the notice) and the general nature of that business The notice shall also specify, with reasonable prominence, that a member entitled to attend and vote is entitled to appoint one or more proxies to attend, speak and vote instead of him, and that a proxy need not also be a member For the avoidance of doubt the Board shall be under no obligation to offer or provide such Electronic Facility or facilities, whatever the circumstances

If the Board determines that a general meeting shall be held partly by means of Electronic Facility or facilities, the notice shall

- (a) include a statement to that effect,
- (b) specify the means, or all different means, of attendance and participation thereat, and any access, identification and security arrangements determined in accordance with Article 51 2, and
- (c) state how it is proposed that persons attending or participating in the meeting by Electronic Facility or facilities should communicate with each other during the meeting

Contents of notice additional requirements 49 2 In the case of an annual general meeting, the notice shall specify the meeting as such In the case of a meeting to pass a special resolution, the notice shall specify the intention to propose the resolution as a special resolution

Article 50 3 arrangements 49 3 The notice shall include details of any arrangements made for the purpose of Article 50 3 (making clear that participation in those arrangements will not amount to attendance at the meeting to which the notice relates)

General meetings at more than one place 50 1 Provided that at least one member is present in person or by proxy at the place designated as the principal meeting place, the Board may resolve to enable persons entitled to attend a general meeting to do so by simultaneous attendance and participation at a satellite meeting place anywhere in the world The members present in person or by proxy at satellite meeting places shall be counted in the quorum for, and entitled to vote at, the general meeting in question, and that meeting shall be duly constituted and its proceedings valid if the chairman of the general meeting is satisfied that adequate facilities are available throughout the general meeting to ensure that members attending at all the meeting places are able to

- (a) participate in the business for which the meeting has been convened,
- (b) hear and see all persons who speak (whether by the use of microphones, loudspeakers, audio-visual communications equipment or otherwise) in the principal meeting place and any satellite meeting place, and
- (c) be heard and seen by all other persons so present in the same way

The chairman of the general meeting shall be present at, and the meeting shall be deemed to take place at, the principal meeting place

The Board may also resolve to enable persons entitled to attend and participate in a general meeting to do so by simultaneous attendance and participation by means of Electronic Facility or facilities, and may determine the means, or all different means, of attendance and participation used in relation to the general meeting. The members present in person or by proxy by means of an Electronic Facility or facilities (as so determined by the Board) shall be counted in the quorum for, and be entitled to participate in, the general meeting in question. That meeting shall be duly constituted and its proceedings valid if the chair is satisfied that adequate facilities are available throughout the meeting to ensure that members attending the meeting by all means (including the means of an Electronic Facility or facilities) are able to

- (a) participate in the business for which the meeting has been convened,
- (b) hear all persons who speak at the meeting, and
- (c) be heard by all other persons attending and participating in the meeting

Interruption or adjournment where facilities inadequate

50 2 If it appears to the chairman of the general meeting that the facilities at the principal meeting place or any satellite meeting place have become inadequate for the purposes referred to in Article 50 1, then the chairman may, without the consent of the meeting, interrupt or adjourn the general meeting. All business conducted at that general meeting up to the time of that adjournment shall be valid. The provisions of Article 56 2 shall apply to that adjournment.

Other arrangements for viewing/hearing proceedings

50 3 The Board may make arrangements for persons entitled to attend a general meeting or an adjourned general meeting to be able to view and hear the proceedings of the general meeting or adjourned general meeting and to speak at the meeting (whether by the use of microphones, loudspeakers, audio-visual communications equipment or otherwise) by attending at a venue anywhere in the world not being a satellite meeting place. Those attending at any such venue shall not be regarded as present at the general meeting or adjourned general meeting and shall not be entitled to vote at the meeting at or from that venue. The inability for any reason of any member present in person or by proxy at such a venue to view or hear all or any of the proceedings of the meeting or to speak at the meeting shall not in any way affect the validity of the proceedings of the meeting.

Controlling level of attendance

50 4 The Board may from time to time make any arrangements for controlling the level of attendance at any venue for which arrangements have been made pursuant to Article 50 3 (including without limitation the issue of tickets or the imposition of some other means of selection) in its absolute discretion considers appropriate, and may from time to time change those arrangements. If a member, pursuant to those arrangements, is not entitled to attend in person or

by proxy at a particular venue, he shall be entitled to attend in person or by proxy at any other venue for which arrangements have been made pursuant to Article 50 3 The entitlement of any member to be present at such venue in person or by proxy shall be subject to any such arrangement then in force and stated by the notice of meeting or adjourned meeting to apply to the meeting

Change in place and/or time of meeting

50 5 If, after the giving of notice of a general meeting but before the meeting is held, or after the adjournment of a general meeting but before the adjourned meeting is held (whether or not notice of the adjourned meeting is required), the Board decides that it is impracticable or unreasonable for a reason beyond its control to hold the meeting at the declared place (or any of the declared places, in the case of a meeting to which Article 50 1 applies) and/or time, it may change the place (or any of the places, in the case of a meeting to which Article 50 1 applies) and/or postpone the time at which the meeting is to be held If such a decision is made, the Board may then change the place (or any of the places, in the case of a meeting to which Article 50 1 applies) and/or postpone the time again if it decides that it is reasonable to do so in either case

- (a) no new notice of the meeting need be given, but the Board shall, if practicable, advertise the date, time and place of the meeting in at least two newspapers having a national circulation and shall make arrangements for notices of the change of place and/or postponement to appear at the original place and/or at the original time, and
- (b) notwithstanding Article 77(a), an instrument of proxy in relation to the meeting may be deposited at any time not less than 48 hours before any new time appointed for holding the meeting

Meaning of participate

50 6 For the purposes of this Article 50, and subject to Article 55, the right of a member to participate in the business of any general meeting shall include without limitation the right to speak, vote on a show of hands, vote on a poll, be represented by a proxy and have access to all documents which are required by the Companies Acts or these Articles to be made available at the meeting

Accidental omission to give notice

51 1 The accidental omission to give notice of a meeting, or a resolution intended to be moved at a general meeting or to send a form of proxy or invitation to appoint a proxy where required by these Articles, to any person entitled to receive it, or the non-receipt of a notice of meeting or resolution or form of proxy or invitation to appoint a proxy by that person, shall not invalidate the proceedings at that meeting and shall be disregarded for the purpose of determining whether notice of the meeting or of any resolution to be moved at the general meeting is duly given

Security

51 2 The Board and, at any general meeting, the chairman may make any

arrangement and impose any requirement or restriction it or he considers appropriate to ensure the security of a general meeting including, without limitation, requirements for evidence of identity to be produced by those attending the meeting, the searching of their personal property and the restriction of items that may be taken into the meeting place. The Board and, at any general meeting, the chairman are entitled to

- (a) refuse entry to a person who refuses to comply with these arrangements, requirements or restrictions, and
- (b) eject from a meeting any person who causes the proceedings to become disorderly

If a general meeting is held partly by means of an Electronic Facility or facilities pursuant to Article 50 1, the Board and the chairman may make any arrangement and impose any requirement or restriction that is

- (a) necessary to ensure the identification of those taking part by means of such Electronic Facility or facilities and the security of the Electronic Communication, and
- (b) in its or his or her view, proportionate to those objectives,

In this respect, the Board may authorise any voting application, system or facility for attendance and participation as it sees fit

PROCEEDINGS AT GENERAL MEETINGS

Quorum

52 No business shall be transacted at any general meeting unless a quorum is present, but the absence of a quorum shall not preclude the choice or appointment of a chairman, which shall not be treated as part of the business of the meeting. Save as otherwise provided by these Articles, two members present in person being either members or representatives (in the case of a corporate member) or proxies appointed by members in relation to the meeting and entitled to vote on the business to be transacted shall be a members quorum

If quorum not present

53 If such a quorum is not present within five minutes (or such longer time not exceeding 30 minutes as the chairman of the meeting may decide to wait) from the time appointed for the meeting, or if during a meeting such a quorum ceases to be present, the meeting, if convened on the requisition of members, shall be dissolved, and in any other case shall stand adjourned to such time and place with such means of attendance and participation (including partly but not wholly by means of Electronic Facility or facilities) as the chairman of the meeting (or, in default, the Board) may determine. The adjourned meeting shall

be dissolved if a quorum is not present within 15 minutes after the time appointed for holding the meeting

Chairman 54 The chairman, if any, of the Board or, in his absence, any deputy chairman of the Company or, in his absence, some other Director nominated by the Board, shall preside as chairman of the meeting. If neither the chairman, deputy chairman nor such other Director (if any) is present within five minutes after the time appointed for holding the meeting or is not willing to act as chairman, the Directors present shall elect one of their number to be chairman. If there is only one Director present and willing to act, he shall be chairman. If no Director is willing to act as chairman, or if no Director is present within five minutes after the time appointed for holding the meeting, the members present in person or by proxy or by corporate representative and entitled to vote shall choose one of their number to be chairman.

Entitlement to speak 55 1 A Director shall, notwithstanding that he is not a member, be entitled to attend and speak at any general meeting and at any separate meeting of the holders of any class of shares in the capital of the Company.

55 2 All persons seeking to attend and participate in a general meeting by way of Electronic Facility or facilities shall be responsible for maintaining adequate facilities to enable them to do so. Subject only to the requirement for the chair to adjourn a general meeting in accordance with the Article 56, any inability of a person or persons to attend or participate in a general meeting by way of Electronic Facility or facilities shall not invalidate the proceedings of that meeting.

55 3 Nothing in these Articles authorises or allows a general meeting to be held exclusively on an electronic basis.

Adjournments chairman's powers 56 1 The chairman may, with the consent of a meeting at which a quorum is present (and shall if so directed by the meeting), adjourn the meeting from time to time and from place to place (or, in the case of a meeting held at a principal meeting place and one or more satellite meeting places, such other places) and/or from such Electronic Facility or facilities for attendance and participation to such other Electronic Facility or facilities as the meeting shall determine. No business shall be transacted at an adjourned meeting other than business which might properly have been transacted at the meeting had the adjournment not taken place. In addition (and without prejudice to the chairman's power to adjourn a meeting conferred by Article 50 2), the chairman may adjourn the meeting without the consent of the meeting to another time and place (or places in the case of a meeting to which Article 50 1 applies) without such consent if it appears to him that

- (a) it is likely to be impracticable to hold or continue that meeting because of the number of members wishing to attend who are not present, or
- (b) the unruly conduct of persons attending the meeting prevents or is likely to prevent the orderly continuation of the business of the meeting, or
- (c) an adjournment is otherwise necessary so that the business of the meeting may be properly conducted, or
- (d) the facilities or security at the place of the meeting (or places in the case of a satellite meeting) or the Electronic Facility or facilities provided for the meeting have become inadequate or are otherwise not sufficient to allow the meeting to be conducted as intended

Adjournments
procedures

56 2 Any such adjournment may be for such time and to such other place (or, in the case of a meeting held at a principal meeting place and a satellite meeting place, such other places) as the chairman may, in his absolute discretion determine, notwithstanding that by reason of such adjournment some members may be unable to be present at the adjourned meeting Any such member may nevertheless execute a form of proxy for the adjourned meeting which, if delivered by him to the chairman or the secretary (in accordance with the provisions of these Articles), shall be valid even though it is given at less notice than would otherwise be required by these Articles When a meeting is adjourned for 30 days or more or for an indefinite period, at least seven Clear Days' notice shall be given specifying the time and place (or places, in the case of a meeting to which Article 50 1 applies) of the adjourned meeting and the general nature of the business to be transacted Otherwise it shall not be necessary to give any notice of an adjournment or of the business to be transacted at an adjourned meeting

Amendments to
resolutions

57 If an amendment is proposed to any resolution under consideration but is in good faith ruled out of order by the chairman, the proceedings on the substantive resolution shall not be invalidated by any error in such ruling With the consent of the chairman, an amendment may be withdrawn by its proposer before it is voted on No amendment to a resolution duly proposed as a special resolution may be considered or voted on (other than a mere clerical amendment to correct a patent error) No amendment to a resolution duly proposed as an ordinary resolution may be considered or voted on (other than a mere clerical amendment to correct a patent error) unless either (a) at least 48 hours before the time appointed for holding the meeting or adjourned meeting at which the ordinary resolution is to be considered, notice of the terms of the amendment and the intention to move it has been lodged at the office, or (b) the chairman in his absolute discretion decides that the amendment may be considered and voted on

Methods of voting 58 A resolution put to the vote at a general meeting held partly by means of Electronic Facility or facilities, shall be decided on a poll, which poll votes may be cast by such Electronic Means as the Board, in its sole discretion, deems appropriate for the purposes of the meeting Any such poll shall be deemed to have been validly demanded at the time fixed for the holding of the meeting to which it relates Subject thereto, a resolution put to the vote of a general meeting shall be decided on a show of hands unless, before or on the declaration of the result of a vote on the show of hands or on the withdrawal of any other demand for a poll, a poll is duly demanded Subject to the provisions of the Companies Acts, a poll may be demanded by

- (a) the chairman of the meeting, or
- (b) at least five members present in person or by proxy having the right to vote at the meeting, or
- (c) any member or members present in person or by proxy representing not less than one-tenth of the total voting rights of all the members having the right to vote at the meeting (excluding any voting rights attached to any shares in the Company held as treasury shares), or
- (d) any member or members present in person or by proxy holding shares conferring a right to vote on the resolution being shares on which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all the shares conferring that right (excluding shares in the Company conferring a right to vote on the resolution which are held as treasury shares), or
- (e) any member, present in person or by proxy, in the case of a resolution to confer, vary, revoke or renew authority or approval for an off-market purchase by the Company of its own shares, and a demand by a person as proxy for a member shall be the same as a demand by the member

A demand by a person as proxy for a member shall be the same as a demand by the member

Declaration of result 59 Unless a poll is duly demanded (and the demand is not withdrawn with the consent of the chairman before the poll is taken) a declaration by the chairman that a resolution has been carried or carried unanimously, or by a particular majority, or lost, or not carried by a particular majority shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour of or against the resolution

Chairman's casting 60 In the case of an equality of votes, whether on a show of hands or on a

vote poll, the chairman shall not be entitled to a casting vote in addition to any other vote he may have

Withdrawal of demand for poll 61 The demand for a poll may be withdrawn before the poll is taken, but only with the consent of the chairman. A demand so withdrawn shall not be taken to have invalidated the result of a show of hands declared before the demand was made. If the demand for a poll is withdrawn, the chairman or any other member entitled may demand a poll.

Conduct of poll 62 Subject to Article 63, a poll shall be taken as the chairman directs and he may, and shall if required by the meeting, appoint scrutineers (who need not be members) and fix a time and place for declaring the result of the poll. The result of the poll shall be the decision of the meeting in respect of which it was demanded.

When poll to be taken 63 A poll demanded on the election of a chairman or on a question of adjournment shall be taken at the meeting at which it is demanded. A poll demanded on any other question shall be taken either at the meeting or at such time and place as the chairman directs not being more than 30 days after the poll is demanded, and by such means of attendance and participation (including at such place or places and/or by means of such Electronic Facility or facilities) as the chair directs. The demand for a poll shall not prevent the continuance of a meeting for the transaction of any business other than the question on which the poll was demanded. If a poll is demanded before the declaration of the result of a show of hands and the demand is duly withdrawn, the meeting shall continue as if the demand had not been made.

Notice of poll 64 No notice need be given of a poll not taken at the meeting at which it is demanded if the time and place at which it is to be taken are announced at the meeting. In any other case at least seven Clear Days' notice shall be given specifying the time and place at which the poll is to be taken.

Effectiveness of special resolutions 65 Where for any purpose an ordinary resolution of the Company is required, a special resolution shall also be effective.

66 For the purposes of determining which persons are entitled to attend or vote at a general meeting and how many votes such person may cast, the Company may specify in the notice of the general meeting a time by which a person must be entered on the register of members in order to have the right to attend or vote at the meeting.

VOTES OF MEMBERS

Right to vote 67 1 Subject to any terms as to voting upon which any shares may be issued or

may for the time being be held, a member present in person or (being a corporation) who is present by a duly authorised representative or a proxy for a member entitled to vote on the resolutions has on a show of hands one vote. On a poll every member present in person or by proxy or by representative (in the case of a corporate member) shall have one vote for each share of which he is the holder, proxy or representative. On a poll, a member entitled to more than one vote need not, if he votes, use all his votes or cast all the votes in the same way.

67.2 Subject to any rights or restrictions attached to shares, on a vote on a resolution on a show of hands at a meeting, a proxy has one vote for and one vote against the resolution if

- (a) the proxy has been duly appointed by more than one member entitled to vote on the resolution, and
- (b) the proxy has been instructed by one or more of those members to vote for the resolution and by one or more other of those members to vote against it.

Votes of joint holders

68 In the case of joint holders of a share, the vote of the senior who tenders a vote, whether in person or by proxy, shall be accepted to the exclusion of the votes of the other joint holders. For this purpose seniority shall be determined by the order in which the names of the holders stand in the register.

Member under incapacity

69 A member in respect of whom an order has been made by a court or official having jurisdiction (whether in the United Kingdom or elsewhere) in matters concerning mental disorder may vote, whether on a show of hands or on a poll, by his receiver, curator bonis or other person authorised for that purpose appointed by that court or official. That receiver, curator bonis or other person may, on a poll, vote by proxy. The right to vote shall be exercisable only if evidence satisfactory to the Board of the authority of the person claiming to exercise the right to vote has been deposited at the office, or at another place specified in accordance with these Articles for the deposit of instruments of proxy, not less than 48 hours before the time appointed for holding the meeting or adjourned meeting at which the right to vote is to be exercised or, in the case of a poll taken subsequently at the meeting or first meeting, not less than 24 hours before the time appointed for the taking of the poll. In calculating the periods mentioned in this Article no account shall be taken of any part of a day that is not a working day.

Calls in arrears

70 Unless the Board otherwise determines, no member shall be entitled to attend or vote at a general meeting or at a separate meeting of the holders of any class of shares in the capital of the Company, either in person or by proxy, in respect of any share held by him, or exercise any other right or privilege

conferred by membership in relation to any such meeting or poll, unless all monies presently payable by him in respect of that share have been paid

Section 793 of the Act restrictions if in default

70 1 If at any time the Board is satisfied that any member, or any other person appearing to be interested in shares held by such member, has been duly served with a notice under section 793 of the Act (a *section 793 notice*) and is in default for the prescribed period in supplying to the Company the information thereby required, or, in purported compliance with such a notice, has made a statement which is false or inadequate in a material particular, then the Board may, in its absolute discretion at any time thereafter by notice (a *direction notice*) to such member, direct that

- (a) in respect of the shares in relation to which the default occurred (the *default shares*, which expression includes any shares issued after the date of the section 793 notice in respect of those shares) the member shall not be entitled to attend or vote either personally or by proxy at a general meeting or at a separate meeting of the holders of that class of shares or on a poll or to exercise any other right or privilege in relation to any general meeting or any meeting of the holders of any class of shares, and/or
- (b) where the default shares represent at least one quarter of one per cent in nominal value of the issued shares of their class, the direction notice may additionally direct that in respect of the default shares
 - (i) no payment shall be made by way of Dividend and no share shall be allotted pursuant to Article 141,
 - (ii) no transfer of any default share shall be effective or shall be registered by the Company unless
 - (A) the member is not himself in default as regards supplying the information requested and the transfer when presented for registration is accompanied by a certificate by the member in such form as the Board may in its absolute discretion require to the effect that after due and careful enquiry the member is satisfied that no person in default as regards supplying such information is interested in any of the shares the subject of the transfer, or
 - (B) the transfer is an approved transfer, or
 - (C) registration of the transfer is required by the Regulations, and/or

- (iii) no Dividend (or other moneys payable) shall be paid in respect of the restricted shares and that, in circumstances where an offer of the right to elect to receive shares instead of cash in respect of any Dividends is or has been made, any election made thereunder in respect of such specified shares shall not be effective

Copy of notice to interested persons 70 2 The Company shall send a copy of the direction notice to each other person appearing to be interested in the default shares, but the failure or omission by the Company to do so shall not invalidate such notice

When restrictions cease to have effect 70 3 Any direction notice shall cease to have effect not more than seven days after the earlier of receipt by the Company of

- (a) a notice of an approved transfer, but only in relation to the shares transferred, or
- (b) all the information required by the relevant section 793 notice, in a form satisfactory to the Board

and where Dividends or other moneys are not paid as a result of restrictions having been imposed on restricted shares, such Dividends or other moneys shall accrue and, upon the relevant restriction ceasing to apply, shall be payable (without interest) to the person who would have been entitled has the restriction not been imposed

Board may cancel restrictions 70 4 The Board may at any time give notice cancelling a direction notice

Conversion of Uncertificated Shares 70 5 The Company may exercise any of its powers under Article 8 3 in respect of any default share that is held in uncertificated form

Provisions supplementary to Article 70 71 1 For the purposes of Article 70

- (a) a person shall be treated as appearing to be interested in any shares if the member holding such shares has given to the Company a notification under section 793 of the Act which either (i) names such person as being so interested or (ii) fails to establish the identities of all those interested in the shares, and (after taking into account the said notification and any other relevant section 793 notification) the Company knows or has reasonable cause to believe that the person in question is or may be interested in the shares,
- (b) the prescribed period is 14 days from the date of service of the section 793 notice, and

- (c) a transfer of shares is an approved transfer if
 - (i) it is a transfer of shares pursuant to an acceptance of a takeover offer for the Company (within the meaning of section 974(1)-(3) of the Act), or
 - (ii) the Board is satisfied that the transfer is made pursuant to a sale of the whole of the beneficial ownership of the shares the subject of the transfer to a party unconnected with the member and with any other person appearing to be interested in the shares, or
 - (iii) the transfer results from a sale made through a recognised investment exchange as defined in the Financial Services and Markets Act 2000 (as amended from time to time) or any other stock exchange outside the United Kingdom on which the Company's shares are normally traded

Section 794 of the Act 71 2 Nothing contained in Article 70 limits the power of the Company under section 794 of the Act

Errors in voting 72 If any votes are counted which ought not to have been counted, or might have been rejected, the error shall not vitiate the result of the voting unless it is pointed out at the same meeting, or at any adjournment of the meeting, and, in the opinion of the chairman, it is of sufficient magnitude to vitiate the result of the voting

Objection to voting 73 No objection shall be raised to the qualification of any person voting at the general meeting except at the meeting or adjourned meeting or poll at which the vote objected to is tendered Every vote not disallowed at such meeting shall be valid and every vote not counted which ought to have been counted shall be disregarded Any objection made in due time shall be referred to the chairman whose decision shall be final and conclusive

No obligation to verify proxy voting in accordance with instructions 74 The Company is not obliged to verify whether a proxy or corporate representative has voted in accordance with the instructions given by the member by whom the proxy or corporate representative is instructed Any vote (whether given on a show of hands or a on poll) is not invalidated if a proxy or corporate representative does not vote in accordance with their instructions

PROXIES AND CORPORATE REPRESENTATIVES

Appointment of proxy 75 An instrument appointing a proxy shall be executed by or on behalf of the appointor or his attorney

Form of proxy 76 1 Instruments of proxy shall be in any usual form or in any other form which the Board may approve. The Board may, if it thinks fit, but subject to the provisions of the Companies Acts, at the Company's expense send out forms of instrument of proxy for use at the meeting with the notice of any meeting. Delivery of an instrument appointing a proxy shall not preclude a member from attending and voting in person at the meeting or poll concerned.

76 2 Subject to section 324(2) of the Act, a member may appoint more than one proxy to attend on the same occasion provided that each proxy is appointed to exercise the rights attached to a different share or shares held by that member and a person entitled to more than one vote need not use all his votes or cast all the votes he uses in the same way. A person appointed to act as a proxy need not be a member of the Company.

Delivery of form of proxy 77 The instrument appointing a proxy and any power of attorney or other written authority under which it is executed or an office or notarially certified copy or a copy certified in accordance with the Powers of Attorney Act 1971 of such power or written authority shall

- (a) in the case of an instrument in writing be deposited by personal delivery, post or facsimile transmission at the office or at such other place within the United Kingdom as is specified in the notice convening the meeting or in any instrument of proxy sent out by the Company in relation to the meeting not fewer than 48 hours before the time appointed for holding the meeting or adjourned meeting at which the person named in the instrument proposes to vote, or
- (b) in the case of an appointment contained in an Electronic Communication, where an address has been specified for the purpose of receiving Electronic Communications
 - (i) in the notice convening the meeting, or
 - (ii) in any instrument of proxy sent out by the Company in relation to the meeting, or
 - (iii) in any invitation contained in any Electronic Communication to appoint a proxy issued by the Company in relation to the meeting,

be received at such address not fewer than 48 hours before the time for holding the meeting or adjourned meeting at which the person named in the appointment proposes to vote, or

- (c) in the case of a poll taken more than 48 hours after it is demanded, be deposited as aforesaid after the poll has been demanded and not fewer than 24 hours before the time appointed for the taking of the poll, or
- (d) where the poll is not taken immediately but is taken not more than 48 hours after it was demanded, be delivered at the meeting at which the poll was demanded to the chairman or to the secretary or to any Director. In calculating the periods mentioned in this Article no account shall be taken of any part of a day that is not a working day

An instrument of proxy which is not deposited or delivered in any such manner shall be invalid. No instrument of proxy shall be valid more than 12 months after the date stated in it as the date of its execution. When two or more valid but differing appointments of proxy are deposited, delivered or received in respect of the same share for use at the same meeting, the one which is deposited with, delivered to or received by the Company (in accordance with the provisions of this Article) last in time (regardless of the date of its making or transmission) shall be treated as revoking and replacing any others as regards that share, but if the Company is unable to determine which of any such two or more valid but differing instruments of proxy was so deposited, delivered or received last in time, none of them shall be treated as valid in respect of that share.

In this Article *address*, in relation to Electronic Communications, includes any number or address used for the purpose of such communications.

Validity of form of proxy

78 An instrument appointing a proxy shall be deemed to include the right to demand, or join in demanding, a poll. The instrument of proxy shall also be deemed to confer authority to speak and vote on any amendment of a resolution put to the meeting for which it is given as the proxy thinks fit. The instrument of proxy shall, unless it provides to the contrary, be valid for any adjournment of the meeting as well as for the meeting to which it relates. If the Chairman of the meeting has been appointed as proxy by more than one member and has received conflicting instructions on how to vote in respect of any particular resolution, he may exercise his discretion not to vote on a show of hands in respect of that particular resolution.

Corporate representatives

79 Any corporation or corporation sole which is a member of the Company (in this Article the *grantor*) may (in the case of a corporation, by resolution of its Directors or other governing body or by authority to be given under seal or under the hand of an officer duly authorised by it) authorise such person as it thinks fit to act as its representative at any meeting of the Company or at any separate meeting of the holders of any class of shares. A person so authorised shall be entitled to exercise the same power on behalf of the grantor as the grantor could

exercise if it were an individual member of the Company. Such representative or representatives may be required to produce a copy of such resolution or authority certified by a proper officer of such corporation before being permitted to exercise his or their power.

80 A corporation which is a member of the Company may authorise more than one person to act as its representative pursuant to this Article in respect of any meeting or meetings, and such a member who holds different classes of shares may so authorise one or more different persons for each class of shares held.

NUMBER OF DIRECTORS

Limits on number of Directors 81 Unless otherwise determined by ordinary resolution, the number of Directors (other than alternate Directors) shall be not fewer than two but shall not be subject to any maximum in number.

APPOINTMENT AND RETIREMENT OF DIRECTORS

Number of Directors to retire 82 1 Subject to Article 82 2, at each annual general meeting one-third of the Directors shall retire from office or, if their number is not three or a multiple of three, the number nearest to but greater than one-third shall retire from office by rotation, but

- (a) if any Director has at the start of the annual general meeting been in office for more than three years since his last appointment or re-appointment, he shall retire, and
- (b) if there is only one Director who is subject to retirement by rotation, he shall retire; and

82 2 The Board may in its discretion resolve to retire such number of Directors as is greater than the number of Directors subject to retirement in accordance with Article 82 1.

Which Directors to retire 83 Subject to the provisions of the Companies Acts and these Articles, the Directors to retire by rotation shall be those who have been longest in office since their last appointment or re-appointment. As between persons who became or were last re-appointed Directors on the same day those to retire shall (unless they otherwise agree among themselves) be determined by lot. The Directors to retire on each occasion (both as to number and identity) shall be determined by the composition of the Board at the date of the notice convening the annual general meeting. No Director shall be required to retire or be relieved from retiring or be retired by reason of any change in the number or identity of the

Directors after the date of the notice but before the close of the meeting

When Director deemed to be re-appointed 84 If the Company does not fill the vacancy at the meeting at which a Director retires by rotation or otherwise, the retiring Director shall, if willing to act, be deemed to have been re-appointed unless at the meeting it is resolved not to fill the vacancy or unless a resolution for the re-appointment of the Director is put to the meeting and lost

Eligibility for election and Age of Director 85 1 No person other than a Director retiring by rotation shall be appointed or reappointed a Director at any general meeting unless

- (a) he is recommended by the Board, or
- (b) not fewer than seven nor more than 21 days before the date appointed for the meeting, notice executed by a member qualified to vote at the meeting (not being the person to be proposed) has been given to the Company of the intention to propose that person for appointment stating the particulars which would, if he were so appointed or reappointed, be required to be included in the Company's register of Directors, together with notice executed by that person confirming his willingness to be appointed or reappointed

85 2 No Director shall vacate or be required to vacate his office as a Director on or by reason of his attaining or having attained the age of 70 or any other age, and any Director retiring or liable to retire under the provisions of these Articles and any person proposed to be appointed a Director shall be capable of being appointed or reappointed notwithstanding that he has attained the age of 70 or any other age and no special notice need be given of any resolution for the appointment or reappointment as a Director of a person who shall have attained the age of 70 or any other age

Separate resolutions on appointment 86 Except as otherwise authorised by the Companies Acts, the appointment of any person proposed as a Director shall be effected by a separate resolution

Additional powers of the Company 87 Subject as aforesaid, the Company may by ordinary resolution appoint a person who is willing to act to be a Director either to fill a vacancy or as an additional Director and may also determine the rotation in which any additional Directors are to retire The appointment of a person to fill a vacancy or as an additional Director shall take effect from the end of the meeting

Appointment by board 88 The Board may appoint a person who is willing to act to be a Director, either to fill a vacancy or as an additional Director and in either case whether or not for a fixed term, provided that the appointment does not cause the number of Directors to exceed the number, if any, fixed by or in accordance with these

Articles as the maximum number of Directors Irrespective of the terms of his appointment, a Director so appointed shall hold office only until the next following annual general meeting and shall not be taken into account in determining the Directors who are to retire by rotation at the meeting If not re-appointed at such annual general meeting, he shall vacate office at its conclusion

Position of retiring Directors 89 A Director who retires at an annual general meeting may, if willing to act, be reappointed If he is not re-appointed, he shall retain office until the meeting appoints someone in his place, or if it does not do so, until the end of the meeting

No share qualification 90 A Director, including an alternate Director, shall not be required to hold any shares in the capital of the Company by way of qualification

ALTERNATE DIRECTORS

Power to appoint alternates 91 Any Director (other than an alternate Director) may appoint any other, or any other person approved by resolution of the Board, to be an alternate Director and may remove from office an alternate Director so appointed by him

Alternates entitled to receive notice 92 An alternate Director shall be entitled to receive notice of all meetings of the Board and of all meetings of committees of the Board of which his appointor is a member, to attend and vote at any such meeting at which his appointor is not personally present, and generally to perform all the functions of his appointor (except as regards power to appoint an alternate) as a Director in his absence It shall not be necessary to give notice of such a meeting to an alternate Director who is absent from the United Kingdom

Alternates representing more than one Director 93 A Director or any other person may act as alternate Director to represent more than one Director, and an alternate Director shall be entitled at meetings of the Board or any committee of the Board to one vote for every Director whom he represents (and who is not present) in addition to his own vote (if any) as a Director, but he shall count as only one for the purpose of determining whether a quorum is present

Expenses and remuneration of alternates 94 An alternate Director may be repaid by the Company such expenses as might properly have been repaid to him if he had been a Director but shall not be entitled to receive any remuneration from the Company in respect of his services as an alternate Director except such part (if any) of the remuneration otherwise payable to his appointor as such appointor may by notice in writing to the Company from time to time direct An alternate Director shall be entitled to be indemnified by the Company to the same extent as if he were a Director

Termination of appointment 95 An alternate Director shall cease to be an alternate Director

- (a) if his appointor ceases for any reason to be a Director, but, if a Director retires by rotation or otherwise but is re-appointed or deemed to have been re-appointed at the meeting at which he retires, any appointment of an alternate Director made by him which was in force immediately prior to his retirement shall continue after his re-appointment, or
- (b) on the happening of any event which, if he were a Director, would cause him to vacate his office as Director, or
- (c) if he resigns his office by notice to the Company, or
- (d) if his appointor terminates the appointment, or
- (e) if he is not a Director and the Board revokes its approval of him by resolution

Method of appointment and revocation

96 Any appointment or removal of an alternate Director shall be by notice in writing to the Company signed by the Director making or revoking the appointment and shall take effect in accordance with the terms of the notice (subject to any approval required by Article 91) on receipt of such notice at the office. A notice of appointment must contain a statement signed by the proposed alternate that he is willing to act as the alternate of the Director giving notice.

Alternate not an agent of appointer

97 Except as otherwise expressly provided in these Articles, an alternate Director shall be deemed for all purposes to be a Director. Accordingly, except where the context otherwise requires, a reference to a Director shall be deemed to include a reference to an alternate Director. Every alternate Director shall be an officer of the Company and shall alone be responsible for his own acts and defaults and he shall not be deemed to be the agent of the Director appointing him.

POWERS OF THE BOARD

Business to be managed by board

98 Subject to the provisions of the Companies Acts and these Articles and to any directions given by special resolution, the business of the Company shall be managed by the Board which may exercise all the powers of the Company, including without limitation the power to dispose of all or any part of the undertaking of the Company. No alteration of these Articles and no such direction shall invalidate any prior act of the Board which would have been valid if that alteration had not been made or that direction had not been given. The powers given by this Article shall not be limited by any special power given to the Board by these Articles. A meeting of the Board at which a quorum is present may exercise all powers exercisable by the Board.

Exercise by
Company of voting
rights

99 The Board may exercise the voting power conferred by the shares in any body corporate held or owned by the Company in such manner in all respects as it thinks fit (including without limitation the exercise of that power in favour of any resolution appointing its members or any of them Directors of such body corporate, or voting or providing for the payment of remuneration to the Directors of such body corporate)

DELEGATION OF POWERS OF THE BOARD

Committees of the
Board

100 The Board may delegate any of its powers to any committee consisting of one or more Directors. The Board may also delegate to any Director holding any executive office such of its powers as the Board considers desirable to be exercised by him. Any such delegation shall, in the absence of express provision to the contrary in the terms of delegation, be deemed to include authority to sub-delegate to one or more Directors (whether or not acting as a committee) or to any employee or agent of the Company all or any of the powers delegated and may be made subject to such conditions as the Board may specify, and may be revoked or altered. The Board may co-opt on to any such committee persons other than Directors, who may enjoy voting rights in the committee. The co-opted members shall be less than one-half of the total membership of the committee and a resolution of any committee shall be effective only if a majority of the members present are Directors. Subject to any conditions imposed by the Board, the proceedings of a committee with two or more members shall be governed by these Articles regulating the proceedings of Directors so far as they are capable of applying.

Local boards etc

101 The Board may establish local or divisional boards or agencies for managing any of the affairs of the Company, either in the United Kingdom or elsewhere, and may appoint any persons to be members of the local or divisional boards, or any managers or agents, and may fix their remuneration. The Board may delegate to any local or divisional board, manager or agent any of the powers, authorities and discretions vested in or exercisable by the Board, with power to sub-delegate, and may authorise the members of any local or divisional board, or any of them, to fill any vacancies and to act notwithstanding vacancies. Any appointment or delegation made pursuant to this Article may be made on such terms and subject to such conditions as the Board may decide. The Board may remove any person so appointed and may revoke or vary the delegation but no person dealing in good faith and without notice of the revocation or variation shall be affected by it.

Agents

102 The Board may, by power of attorney or otherwise, appoint any person to be the agent of the Company for such purposes, with such powers, authorities and discretions (not exceeding those vested in the Board) and on such conditions as the Board determines, including without limitation authority for the agent to

delegate all or any of his powers, authorities and discretions, and may revoke or vary such delegation

Offices including the title "Director" 103 The Board may appoint any person to any office or employment having a designation or title including the word Director or attach to any existing office or employment with the Company such a designation or title and may terminate any such appointment or the use of any such designation or title. The inclusion of the word "Director" in the designation or title of any such office or employment shall not imply that the holder is a Director of the Company, and the holder shall not thereby be empowered in any respect to act as, or be deemed to be, a Director of the Company for any of the purposes of these Articles

BORROWING POWERS

Power to borrow 104 Subject to the Act, the Board may exercise all the powers of the Company to:

- (a) borrow money;
- (b) indemnify and guarantee;
- (c) mortgage or charge all or any part of the undertaking, property and assets (present and future) and uncalled capital of the Company;
- (d) create and issue debentures and other securities; and
- (e) give security either outright or as collateral security for any debt, liability or obligation of the Company or of any third party.

DISQUALIFICATION AND REMOVAL OF DIRECTORS

Disqualification as a Director 105 The office of a Director shall be vacated if

- (a) he ceases to be a Director by virtue of any provisions of the Companies Acts or these Articles or he becomes prohibited by law from being a Director, or
- (b) he becomes bankrupt or makes any arrangement or composition with his creditors generally or shall apply to the court for an interim order under section 253 of the Insolvency Act 1986 in connection with a voluntary arrangement under that Act, or
- (c) a registered medical practitioner who is treating him gives a written opinion to the Company stating that that he has become physically or

mentally incapable of acting as a Director and may remain so for more than 3 months, or

- (d) by reason of his mental health, a court makes an order which wholly or partly prevents him from personally exercising any powers or rights which he would otherwise have, or
- (e) he resigns his office by notice to the Company or, having been appointed for a fixed term, the term expires or his office as a Director is vacated pursuant to Article 88, or
- (f) he has been absent for more than six consecutive months without permission of the Board from meetings of the Board held during that period and his alternate Director (if any) has not attended in his place during that period and the Board resolves that his office be vacated, or
- (g) he is convicted of an indictable offence (not being an offence which, in the opinion of the Directors, does not affect his character or position as a Director of the Company), or
- (h) he is requested to resign in writing by not less than three quarters of the other Directors. In calculating the number of Directors who are required to make such a request to the Director, (i) an alternate Director appointed by him acting in his capacity as such shall be excluded, and (ii) a Director and any alternate Director appointed by him and acting in his capacity as such shall constitute a single Director for this purpose, so that the signature of either shall be sufficient, or
- (i) all the other Directors unanimously resolve that his office be vacated, or
- (j) in the case of a person who is also an employee of the Company, he ceases to be such an employee and the Board does not resolve to allow such person to continue in office as a Director,

Power of Company
to remove Director

106 The Company may, without prejudice to the provisions of the Companies Acts, by ordinary resolution remove any Director from office (notwithstanding any provision of these Articles or of any agreement between the Company and such Director, but without prejudice to any claim he may have for damages for breach of any such agreement) No special notice need be given of any resolution to remove a Director in accordance with this Article and no Director proposed to be removed in accordance with this Article has any special right to protest against his removal. The Company may, by ordinary resolution, appoint another person in place of a Director removed from office in accordance with this Article. Any person so appointed shall, for the purpose of determining the time at which

he or any other Director is to retire by rotation, be treated as if he had become a Director on the day on which the Director in whose place he is appointed was last elected a Director In default of such appointment the vacancy arising on the removal of a Director from office may be filled as a casual vacancy

REMUNERATION OF NON-EXECUTIVE DIRECTORS

Ordinary remuneration

107 The ordinary remuneration of the Directors who do not hold executive office for their services (excluding amounts payable under any other provision of these Articles) shall not exceed in aggregate £500,000 per annum or such higher amount as the Company may from time to time by ordinary resolution determine Subject thereto, each such Director shall be paid a fee (which shall be deemed to accrue from day to day) at such rate as may from time to time be determined by the Board

Additional remuneration for special services

108 Any Director who does not hold executive office and who serves on any committee of the Board, by the request of the Board goes or resides abroad for any purpose of the Company or otherwise performs special services which in the opinion of the Board are outside the scope of the ordinary duties of a Director, may (without prejudice to the provisions of Article 107) be paid such extra remuneration by way of salary, commission or otherwise as the Board may determine

DIRECTORS' EXPENSES

Directors may be paid expenses

109 The Directors may be paid all travelling, hotel, and other expenses properly incurred by them in connection with their attendance at meetings of the Board or committees of the Board, general meetings or separate meetings of the holders of any class of shares or of debentures of the Company or otherwise in connection with the discharge of their duties

EXECUTIVE DIRECTORS

Appointment to executive office

110 Subject to the provisions of the Companies Acts, the Board may appoint one or more of its body to be the holder of any executive office (except that of auditor) in the Company and may enter into an agreement or arrangement with any Director for his employment by the Company or for the provision by him of any services outside the scope of the ordinary duties of a Director Any such appointment, agreement or arrangement may be made on such terms, including without limitation terms as to remuneration, as the Board determines The Board may revoke or vary any such appointment but without prejudice to any rights or claims which the person whose appointment is revoked or varied may have against the Company because of the revocation or variation

Termination of

111 Any appointment of a Director to an executive office shall terminate if he

appointment to executive office ceases to be a Director but without prejudice to any rights or claims which he may have against the Company by reason of such cessation. A Director appointed to an executive office shall not cease to be a Director merely because his appointment to such executive office terminates

Emoluments to be determined by the Board 112 The emoluments of any Director holding executive office for his services as such shall be determined by the Board, and may be of any description, including without limitation admission to, or continuance of, membership of any scheme (including any share acquisition scheme) or fund instituted or established or financed or contributed to by the Company for the provision of pensions, life assurance or other benefits for employees or their dependants, or the payment of a pension or other benefits to him or his dependants on or after retirement or death, apart from membership of any such scheme or fund

GRATUITIES, PENSIONS AND INSURANCE

Gratuities and pensions 113 1 The Board may (by establishment of, or maintenance of, schemes or otherwise) provide benefits, whether by the payment of gratuities or pensions or by insurance or otherwise, for any past or present Director or employee of the Company or any of its subsidiary undertakings or any body corporate associated with, or any business acquired by, any of them, and for any member of his family (including a spouse and a former spouse) or any person who is or was dependent on him, and may (as well before as after he ceases to hold such office or employment) contribute to any fund and pay premiums for the purchase or provision of any such benefit

Insurance 113 2 Without prejudice to the provisions of Article 168, the Board may exercise all the powers of the Company to purchase and maintain insurance for or for the benefit of any person who is or was

(a) a Director, officer or employee of the Company, or any body which is or was the holding company or subsidiary undertaking of the Company, or in which the Company or such holding company or subsidiary undertaking has or had any interest (whether direct or indirect) or with which the Company or such holding company or subsidiary undertaking is or was in any way allied or associated, or

(b) a trustee of any pension fund in which employees of the Company or any other body referred to in Article 113 2(a) is or has been interested,

including without limitation insurance against any liability incurred by such person in respect of any act or omission in the actual or purported execution or discharge of his duties or in the exercise or purported exercise of his powers or otherwise in relation to his duties, powers or offices in relation to the relevant

body or fund

Directors not liable to account 113 3 No Director or former Director shall be accountable to the Company or the members for any benefit provided pursuant to this Article. The receipt of any such benefit shall not disqualify any person from being or becoming a Director of the Company.

Section 247 of the Act 114 Pursuant to section 247 of the Act, the Board is hereby authorised to make such provision as may seem appropriate for the benefit of any persons employed or formerly employed by the Company or any of its subsidiary undertakings in connection with the cessation or the transfer of the whole or part of the undertaking of the Company or any subsidiary undertaking. Any such provision shall be made by a resolution of the Board in accordance with section 247 of the Act.

PROCEEDINGS OF THE BOARD

Convening meetings 115 Subject to the provisions of these Articles, the Board may regulate its proceedings as it thinks fit. A Director may, and the secretary at the request of a Director shall, call a meeting of the Board. Notice of a board meeting shall be deemed to be properly given to a Director if it is given to him personally or by word of mouth or sent in writing or by Electronic Communications to him at his last known address or any other address given by him or on his behalf to the Company for this purpose from time to time. A Director absent or intending to be absent from the United Kingdom may request the Board that notices of board meetings shall during his absence be sent or given in writing to him at an address given by him to the Company for this purpose, but such notices need not be given any earlier than notices given to Directors not so absent and, if no such request is made to the Board, it shall not be necessary to give notice of a board meeting to any Director who is for the time being absent from the United Kingdom. No account is to be taken of Directors absent from the United Kingdom when considering the adequacy of the period of notice of the meeting. Questions arising at a meeting shall be decided by a majority of votes. In the case of an equality of votes, the chairman shall have a second or casting vote. Any Director may waive notice of a meeting and any such waiver may be either retrospective or prospective.

In this Article, *address*, in relation to Electronic Communications, includes any number or address used for the purpose of such communications.

Quorum 116 The quorum for the transaction of the business of the Board may be fixed by the Board and unless so fixed at any other number shall be two. A person who holds office only as an alternate Director shall, if his appointor is not present, be counted in the quorum provided that a Director or alternate Director who attends

a meeting of the Board shall for the purposes of a quorum be counted as one person notwithstanding that he also attends such meeting as an alternate Director appointed by more than one Director Any Director who ceases to be a Director at a board meeting may continue to be present and to act as a Director and be counted in the quorum until the termination of the Board meeting if no Director objects

Powers of Directors if number falls below minimum

117 The continuing Directors or a sole continuing Director may act notwithstanding any vacancies in their number, but, if the number of Directors is less than the number fixed as the quorum, the continuing Directors or Director may act only for the purpose of filling vacancies or of calling a general meeting

Chairman and deputy chairman

118 The Board may appoint one of their number to be the chairman, and one of their number to be the deputy chairman, of the Board to hold office for such period as it sees fit and may at any time remove either of them from such office Unless he is unwilling to do so, the Director appointed as chairman, or in his stead the Director appointed as deputy chairman, shall preside at every meeting of the Board at which he is present If there is no Director holding either of those offices, or if neither the chairman nor the deputy chairman is willing to preside or neither of them is present within five minutes after the time appointed for the meeting, the Directors present may appoint one of their number to be chairman of the meeting

VALIDITY OF ACTS OF THE BOARD

119 All acts done by a meeting of the Board, or of a committee of the Board, or by a person acting as a Director or alternate Director, shall, notwithstanding that it be afterwards discovered that there was a defect in the appointment of any Director or any member of the committee or alternate Director or that any of them were disqualified from holding office, or had vacated office, or were not entitled to vote, be as valid as if every such person had been duly appointed and was qualified and had continued to be a Director or, as the case may be, an alternate Director and had been entitled to vote

Resolutions in writing

120 A resolution in writing signed by all the Directors entitled to vote on the resolution at a meeting of the Board or of a committee of the Board (not being less than the number of Directors required to form a quorum of the Board at such meeting) shall be as valid and effectual as if it had been passed at a meeting of the Board or (as the case may be) a committee of the Board duly convened and held For this purpose

(a) a resolution may consist of several documents in hard copy and/or sent by Electronic Means in the like form each signed by one or more Directors provided that all those signing or agreeing to the resolution would have

formed a quorum at such a meeting,

- (b) a resolution signed by an alternate Director need not also be signed by his appointor, and
- (c) a resolution signed by a Director who has appointed an alternate Director need not also be signed by the alternate Director in that capacity

Any such resolution of the Directors shall be annexed or attached to the Directors' minute book

Meetings by
telephone, etc

121 Without prejudice to the first sentence of Article 115, a person entitled to be present at a meeting of the Board or of a committee of the Board shall be deemed to be present for all purposes if he is able (directly or by telephonic or Electronic Facility or any other form of communications equipment (whether in use when these Articles are adopted or developed subsequently)) to speak to and be heard by all those present. A person so participating by telephone or Electronic Facility or any other form of Communication shall be deemed to be present in person at the meeting and shall be counted in a quorum and entitled to vote and be counted in a quorum accordingly. Such a meeting shall be deemed to take place where it is convened to be held or (if no Director is present in that place) where the largest group of those participating is assembled, or, if there is no such group, where the chairman of the meeting is. A resolution passed at any meeting held in the above manner, and signed by the chairman of the meeting, shall be as valid and effectual as if it had been passed at a meeting duly convened and held. The word *meeting* when used in relation to a meeting of the Board or of a committee of the Board in these Articles shall be construed accordingly.

122 A Director who is in any way, directly or indirectly, interested in a proposed transaction or arrangement with the Company must declare, in accordance with the Act, the nature and extent of his interest to the other Directors.

Interests in actual
transactions to be
disclosed

123 A Director who is in any way, directly or indirectly, interested in a transaction or arrangement that has been entered into by the Company must declare, in accordance with the Act, the nature and extent of his interest to the other Directors unless the interest has been declared under Article 122 above.

Issues relating to
declarations of
interest

124 1 For the purposes of Articles 122 and 123

- (a) the declaration of interest must be made at a meeting of the

Directors or by notice in writing to the Directors in accordance with section 184 of the Act or by general notice in accordance with section 185 of the Act,

- (b) if the declaration proves to be or becomes inaccurate or incomplete, a further declaration must be made,
- (c) a declaration in respect of a proposed transaction or arrangement must be made as soon as possible as is reasonably practicable,
- (d) a declaration of an interest of which the Director is not aware or where the Director is not aware of the transaction or arrangement in question is not required, and
- (e) an interest of a person who is connected with a Director shall be treated as an interest of the Director

When a declaration is not required 124 2 A Director need not declare an interest under Article 122 and 123

- (a) if it cannot reasonably be regarded as likely to give rise to a conflict of interest,
- (b) if, or to the extent that, the other Directors are already aware of it (and for those purpose the other Directors are treated as aware of anything of which they ought reasonably to be aware), or
- (c) if, or to the extent that, it concerns terms of his service contract that have been or are to be considered
 - (i) by a meeting of the Directors, or
 - (ii) by a committee of the Directors appointed for the purpose under the Articles

Permitted interests 124 3 Subject to the provisions of the Act, and provided that he has disclosed to the Board the nature and extent of any interest of his in accordance with Articles 122 and 123, a Director notwithstanding his office

- (a) may be a party to, or otherwise interested in, any transaction or arrangement with the Company or in which the Company is otherwise interested,
- (b) may be a Director or other officer of, or employed by, or a party to any transaction or arrangement with, or otherwise interested in, any

body corporate promoted by the Company or in which the Company is otherwise interested, and

- (c) shall not, by reason of his office, be accountable to the Company for any benefit which he derives from any such office or employment or from any such transaction or arrangement or from any interest in any such body corporate and no such transaction or arrangement shall be liable to be avoided on the ground of any such interest or benefit

Director may act in a professional capacity 124 4 Any Director may act by himself or his firm in a professional capacity for the Company (otherwise than as auditor) and he or his firm shall be entitled to remuneration for professional services as if he were not a Director

Voting on matters where a Director is interested 124 5 In the case of interests arising under Article 122 or 123, save as otherwise provided in these Articles, a Director shall not vote at a meeting of the Board or of a committee of the Board on any resolution concerning a matter in which he has, directly or indirectly, an interest which is material (otherwise than by virtue of his interest in shares, debentures or other securities of, or otherwise in or through, the Company) unless his interest or duty arises only because the case falls within one or more of the following paragraphs

- (a) the resolution relates to the giving to him or a person connected with him of a guarantee, security or indemnity in respect of money lent to, or an obligation incurred by him or such a person at the request of or for the benefit of, the Company or any subsidiary undertaking,
- (b) the resolution relates to the giving to a third party of a guarantee, security or indemnity in respect of a debt or obligation of the Company or any subsidiary undertaking for which the Director or a person connected with him has assumed responsibility in whole or part and whether alone or jointly with others under a guarantee or indemnity or by the giving of security,
- (c) his interest arises by virtue of him or a person connected with him subscribing or agreeing to subscribe for any shares, debentures or other securities of the Company or any subsidiary undertaking or by virtue of him or a person connected with him being, or intending to become, a participant in the underwriting or sub-underwriting of an offer of any such shares, debentures, or other securities by the Company or any subsidiary undertaking for subscription, purchase or exchange,

- (d) the resolution relates in any way to any other company in which he is interested, directly or indirectly and whether as an officer or shareholder or otherwise howsoever, provided that he and any persons connected with him do not, to his knowledge, hold an interest in shares (as that term is used in Part 22 of the Act) representing one per cent or more of any class of the equity share capital of such company or of the voting rights available to members of such company (excluding any shares in the Company held as treasury shares and any voting rights attached thereto),
- (e) the resolution relates in any way to an arrangement in whole or in part for the benefit of the employees of the Company or any subsidiary undertaking which does not award him as such any privilege or advantage not generally awarded to the employees to whom such arrangement relates,
- (f) the resolution relates in any way to the purchase or maintenance for the Directors of insurance against any liability which by virtue of any rule of law would otherwise attach to all or any of them in respect of any negligence, default, breach of duty or breach of trust in relation to the Company or any subsidiary undertaking

Quorum when a Director is not entitled to vote 124 6 A Director shall not be counted in the quorum present at a meeting in relation to a resolution on which he is not entitled to vote

Proposals may be considered separately 124 7 Where proposals are under consideration concerning the appointment (including fixing or varying the terms of appointment) of two or more Directors to offices or employments with the Company or a body corporate in which the Company is interested the proposals may be divided and considered in relation to each Director separately and (provided he is not for another reason precluded from voting) each of the Directors concerned shall be entitled to vote and be counted in the quorum in respect of each resolution except that concerning his own appointment

Chairman to decide whether a Director may vote 124 8 If a question arises at a meeting of the Board or of a committee of the Board as to the right of a Director to vote or be counted in the quorum and such question is not resolved by his voluntarily agreeing to abstain from voting or not to be counted in the quorum, the question may (unless the Director concerned is the chairman of the meeting in which case he shall withdraw from the meeting and the Board shall elect a new chairman to consider the question in place of the chairman), before the conclusion of the meeting, be referred to the chairman of the meeting and his ruling in relation to any Director other than himself shall be final and conclusive except in a case where the nature or extent of the interest of

the Director concerned has not been fairly disclosed and provided that any such question shall, for the purposes of disclosure of the interest in the accounts of the Company, be finally and conclusively decided by a majority of the Board (other than the Director concerned)

Accountability for benefits 126 7 A Director shall not, save as otherwise agreed by him, be accountable to the Company for any benefit which he (or a person connected with him) derives from any matter authorised by the Directors under Article 125 and any contract, transaction or arrangement relating thereto shall not be liable to be avoided on the grounds of any such benefit

Conflict of duties 126 8 A reference in these Articles to a conflict of interest includes a conflict of interest and duty and a conflict of duties

DIRECTORS' INTERESTS - GENERAL

Connected persons 127 For the purposes of Articles 122 to 126

- (a) an interest of a person connected with a Director shall be treated as an interest of the Director, and
- (b) section 252 of the Act shall determine whether a person is connected with a Director

Suspension or ratification by ordinary resolution 128 The Company may by ordinary resolution suspend or relax to any extent, either generally or in respect of any particular matter, any provision of these Articles prohibiting a Director from voting at a meeting of the Board or of a committee of the Board or ratify any contract, transaction or arrangement, or other proposal, not duly authorised by reason of a contravention of any provisions of these Articles

SECRETARY

Appointment and removal of secretary 129 Subject to the provisions of the Companies Acts, the secretary shall be appointed by the Board for such term, at such remuneration and on such conditions as it may think fit Any secretary so appointed may be removed by the Board, but without prejudice to any claim for damages for breach of any contract of service between him and the Company

130 Anything required or authorised to be done by or to the secretary by the Companies Acts or these Articles may if there are joint secretaries in office be done by or to either of them and, if the office is vacant or there is for any other reason no secretary capable of acting, may be done by or to any assistant or deputy secretary, or, if there is none, by or to any officer of the Company authorised in that behalf by the Directors

MINUTES

Minutes required to be kept 131 1 The Board shall cause minutes to be made in books kept for the purpose of

- (a) all appointments of officers made by the Board, and
- (b) all resolutions of the Company, all proceedings at meetings of the Company, the holders of any class of shares in the capital of the Company, and the Board and committees of the Board, including the names of the Directors present at each such meeting

Conclusiveness of minutes 131 2 Any such minutes, if purporting to be signed by the chairman of the meeting to which they relate or of the meeting at which they are read, shall be sufficient evidence of the proceedings at the meeting without any further proof of the facts stated in them

Retention of minutes 131 3 Any such minutes must be kept for the period specified by the Companies Acts

THE SEAL

Authority required for execution of 132 In addition to its powers under section 44 of the Act, the Company may have a seal and the Board shall provide for the safe custody of such seal The seal shall only be used by the authority of the Board or of a committee of the

deed Board authorised by the Board The Board shall determine who may sign any instrument to which the seal is affixed and, unless otherwise so determined, it shall also be signed by at least one authorised person in the presence of a witness who attests the signature For the purpose of this article an authorised person is any Director of the Company, company secretary or any person authorised by the Directors for the purpose of signing documents to which the common seal is applied

Certificates for shares and debentures 133 All forms of certificates for shares or debentures or representing any other form of security (other than letters of allotment or scrip certificates) shall be issued executed by the Company but the Board may by resolution determine, either generally or in any particular case, that any signatures may be affixed to such certificates by some mechanical or other means or may be printed on them or that such certificates need not bear any signature

Official seal for use abroad 134 If the Company has
(a) an official seal for use abroad, it may only be affixed to a document if its use on that document, or documents of a class to which it belongs, had been authorised by a decision of the Directors, and
(b) a security seal, it may only be affixed to securities by the secretary or a person authorised to apply it to securities by the secretary

REGISTERS

Overseas and local registers 135 Subject to the provisions of the Companies Acts and the Regulations, the Company may keep an overseas or local or other register in any place, and the Board may make, amend and revoke any regulations it thinks fit about the keeping of that register

Authentication and certification of copies and extracts 136 Any Director or the secretary or any other person appointed by the Board for the purpose shall have power to authenticate and certify as true copies of and extracts from
(a) any document comprising or affecting the constitution of the Company,
(b) any resolution passed by the Company, the holders of any class of shares in the capital of the Company, the Board or any committee of the Board, and
(c) any book, record and document relating to the business of the Company (including without limitation the accounts)

If certified in this way, a document purporting to be a copy of a resolution, or the

minutes or an extract from the minutes of a meeting of the Company, the holders of any class of shares in the capital of the Company, the Board or a committee of the Board shall be conclusive evidence in favour of all persons dealing with the Company in reliance on it or them that the resolution was duly passed or that the minutes are, or the extract from the minutes is, a true and accurate record of proceedings at a duly constituted meeting

DIVIDENDS

Declaration of Dividends 137 Subject to the provisions of the Companies Acts, the Company may by ordinary resolution declare Dividends in accordance with the respective rights of the members, but no Dividend shall exceed the amount recommended by the Board

Interim Dividends 138 Subject to the provisions of the Companies Acts, the Board may pay interim Dividends if it appears to the Board that they are justified by the profits of the Company available for distribution. If the share capital is divided into different classes, the Board may pay interim Dividends on shares which confer deferred or non-preferred rights with regard to Dividend as well as on shares which confer preferential rights with regard to Dividend, but no interim Dividend shall be paid on shares carrying deferred or non preferred rights if, at the time of payment, any preferential Dividend is in arrear. The Board may also pay at intervals settled by it any Dividend payable at a fixed rate if it appears to the Board that the profits available for distribution justify the payment. If the Board acts in good faith it shall not incur any liability to the holders of shares conferring preferred rights for any loss they may suffer by the lawful payment of an interim Dividend on any shares having deferred or non-preferred rights. An interim Dividend may be declared or paid in accordance with Article 139 2

Apportionment of Dividends 139 1 Except as otherwise provided by the rights attached to shares, all Dividends shall be declared and paid according to the amounts paid up on the shares on which the Dividend is paid, but no amount paid on a share in advance of the date on which a call is payable shall be treated for the purposes of this Article as paid on the share. All Dividends shall be apportioned and paid proportionately to the amounts paid up on the shares during any portion or portions of the period in respect of which the Dividend is paid, but, if any share is allotted or issued on terms providing that it shall rank for Dividend as from a particular date, that share shall rank for Dividend accordingly. Dividends may be paid in any currency

Currency of Dividends 139 2 The Board may agree with any member that Dividends which may at any time or from time to time be declared or become due on his shares in one currency shall be paid or satisfied in another, and may agree the basis of conversion to be applied and how and when the amount to be paid in the other

currency shall be calculated and paid and for the Company or any other person to bear any costs involved

Uncashed
Dividends

139 3 In respect of Dividends or other moneys payable in respect of any shares, cheques or warrants have been sent through the post in accordance with the provisions of these Articles 137 to 145 but have been returned undelivered or left uncashed during the periods for which they are valid or bank transfers or other methods of payment have failed either

- (a) on two consecutive occasions, or
- (b) on any one occasion and reasonable enquiries have failed to establish another address or account of the person entitled to the moneys,

the Company need not thereafter despatch further cheques or warrants or give instructions for bank transfers or other methods of payment in payment of Dividends or other moneys payable on or in respect of the shares in question until the member or other person entitled thereto shall have communicated with the Company and supplied in writing to the office of the Company a new address or account to be used for the purpose

Dividends in specie

different dates, the first date) (the *relevant period*) at least three Dividends in respect of the shares in question have been declared and all Dividend warrants and cheques which have been sent in the manner authorised by these Articles in respect of the shares in question have remained uncashed,

- (b) the Company shall as soon as practicable after expiry of the relevant period have inserted advertisements both in a national daily newspaper and in a newspaper circulating in the area of the last known address of such member or other person giving notice of its intention to sell the shares,
- (c) during the relevant period and the period of three months following the publication of the advertisements referred to in Article 165 1(b) (or, if published on different dates, the first date) the Company has received no indication either of the whereabouts or of the existence of such member or person, and
- (d) if the shares are listed on the London Stock Exchange, notice has been given to the London Stock Exchange of the Company's intention to make such sale before the publication of the advertisements

Transfer on sale 165 2 To give effect to any sale pursuant to Article 165 1, the Board may

- (a) where the shares are held in certificated form, authorise any person to execute an instrument of transfer of the shares to, or in accordance with the directions of, the buyer, or
- (b) where the shares are held in uncertificated form, do all acts and things it considers necessary or expedient to effect the transfer of the shares to, or in accordance with the directions of, the buyer

Effectiveness of transfer 165 3 An Instrument of transfer executed by that person in accordance with Article 165 2(a) shall be as effective as if it had been executed by the holder of, or person entitled by transmission to, the shares. An exercise by the Company of its powers in accordance with Article 165 2(b) shall be as effective as if exercised by the registered holder of or person entitled by transmission to the shares. The transferee shall not be bound to see to the application of the purchase monies, and his title to the shares shall not be affected by any irregularity in, or invalidity of, the proceedings in reference to the sale

Proceeds of sale 165 4 The net proceeds of sale shall belong to the Company which shall be obliged to account to the former member or other person previously entitled for an amount equal to the proceeds. The Company shall enter the name of such former member or other person in the books of the Company as a creditor for that amount. In relation to the debt, no trust is created and no interest is payable

- (b) criminal proceedings in relation to the Company or an associated company (other than a fine imposed in such proceedings, or a liability incurred in defending proceedings in which the Director is convicted and the conviction is final),
- (c) regulatory action taken by or a regulatory investigation by a regulatory

authority in relation to the Company or an associated company (unless a sum is payable to a regulatory authority by way of a penalty in respect of non-compliance with any requirement of a regulatory nature (however arising)),

- (d) any application for relief
 - (i) under section 661(3) or (4) of the Act (power of court to grant relief in case of acquisition of shares by innocent nominee), or
 - (ii) section 1157 of the Act (general power of court to grant relief in case of honest and reasonable conduct), unless the court refuses to grant the Director relief and the refusal of relief is final, or
- (e) civil proceedings in relation to an occupational pension scheme (as defined in section 235(6) of the Act) of which the Company is a trustee in respect of liability incurred in connection with the Company's activities as a trustee of the scheme (other than a fine imposed in criminal proceedings, a sum payable to a regulatory authority by way of a penalty in respect of non-compliance with any requirement of a regulatory nature (however arising) or a liability incurred in defending proceedings in which the Director is convicted and the conviction is final)

169.3 Notwithstanding any other provision of these Articles, if any shares are issued or transferred from treasury to any person (other than to any Rolling

Manager (as defined in the Scheme), Bidco, a Bidco Company or its nominee(s)) (a “New Member”) at or after the Scheme Record Time (as defined in the Scheme) (the “Post-Scheme Shares”), such Post-Scheme Shares shall, subject to the Scheme becoming Effective, be immediately transferred to Bidco (or such person as Bidco may direct) (the “Purchaser”) by the New Member (or any nominee of such New Member) in consideration of the payment to the New Member of an amount in cash for each Post-Scheme Share equal to the cash consideration which such New Member would have been entitled to receive had each Post-Scheme Share been a Scheme Share (as applicable, after deduction of any tax and social security contributions their employer or any other company is required to withhold or account for in respect of either that consideration or the issue of the shares to the New Member).

169.4 On any reorganisation of, or material alteration to, the share capital of the Company (including, without limitation, any subdivision and/or consolidation) effected after the Effective Date (as defined in the Scheme), the value of the consideration per Post-Scheme Share to be paid under Article 169.3 above shall be adjusted by the Board in such manner as the auditors of the Company or an independent investment bank selected by the Company may determine to be fair and reasonable to reflect such reorganisation or alteration. References in this Article to shares shall, following such adjustment, be construed accordingly.

169.5 To give effect to any transfer of Post-Scheme Shares required by this Article, the Company may appoint any person as attorney and/or agent for the New Member to execute and deliver as transferor a form or forms of transfer or other instrument(s) or instruction(s) of transfer on behalf of the New Member to transfer the Post-Scheme Shares to the Purchaser or its nominee(s) and do all such other things and execute and deliver all such documents as may in the opinion of such attorney or agent be necessary or desirable to vest the Post-Scheme Shares in the Purchaser or its nominee(s) and pending such vesting to exercise all such rights attaching to the Post-Scheme Shares as the Purchaser may direct. If an attorney or agent is so appointed, the New Member shall not thereafter (except to the extent that such attorney or agent fails to act in accordance with the directions of the Purchaser) be entitled to exercise any rights attaching to the Post-Scheme Shares unless so agreed in writing by the Purchaser. The attorney or agent shall be empowered to execute and deliver as transferor a form or forms of transfer or other instrument(s) or instruction(s) of transfer on behalf of the New Member in favour of the Purchaser or its nominee(s) and the Company may give a good receipt for the consideration for the Post-Scheme Shares and may register the Purchaser or its nominee(s) as holder thereof and issue to it certificates for the same. The Company shall not be obliged to issue a certificate to the New Member for the Post-Scheme Shares. The Purchaser shall settle the consideration due to the New Member pursuant to

Article 169.3 above by sending a cheque drawn on a UK clearing bank (or shall procure that such a cheque is sent) in favour of the New Member for the consideration for each Post-Scheme Share, or by an alternative method communicated by the Purchaser to the New Member, and in each case, as soon as practicable and in any event no later than 14 days after the date on which such Post-Scheme Shares are acquired by the Purchaser.

169.6 If the Scheme shall not have become Effective (as defined in the Scheme) by the applicable date referred to in (or otherwise set in accordance with) clause 6.2 of the Scheme (or such later date, if any, as Bidco and the Company may agree and the Court and the Panel on Takeovers and Mergers may allow, if such consent is required), this Article 169 shall be of no effect.

169.7 Notwithstanding any other provision of these Articles, neither the Company nor the Board shall register the transfer of any Scheme Shares effected between the Scheme Record Time and the Effective Date of the Scheme other than to the Purchaser or its nominee(s).
